

FOURSQUARE MAYOR OF SIX FLAGS GIVEAWAY

Official Terms and Conditions

NO PURCHASE OR PAYMENT IS NECESSARY TO PARTICIPATE IN THIS PROMOTION. This promotion is not a sweepstakes, lottery or contest of any kind.

1. ELIGIBILITY. The “Foursquare Mayor of Six Flags Giveaway” (the “Promotion”) is open only to participants who, as of the participation date, are legal residents of the forty-eight (48) contiguous United States (*i.e.*, excluding the States of Alaska and Hawaii) and the District of Columbia, and are at least eighteen (18) years old. The Promotion is void in all other jurisdictions and where prohibited or restricted by law. Employees, agents, representatives, officers and directors of Six Flags Entertainment Corporation (“Six Flags”), Foursquare Labs, Inc. (“Foursquare,” and together with Six Flags, “Sponsors”), and their respective parent companies, subsidiaries, affiliates, advertising and promotional agencies, and the immediate families (defined as spouses and biological, adoptive or step-parents, legal guardians, children, siblings, or grandparents, their respective spouses and any dependent under applicable income tax law) or members of the same household (those who share the same residence, whether related or not) of each are not eligible to enter. The Promotion, and any website pages and advertisements relating thereto, is intended for viewing only within the jurisdictions where the Promotion is offered and participants must be present in the United States or the District of Columbia at the time they enter.

2. PARTICIPATION PERIOD. The Promotion period begins at 12:00 a.m. Eastern Time on June 10, 2010 and ends at 11:59 p.m. Eastern Time on September 7, 2010 (the “Participation Period”). Foursquare’s computer is the official timekeeping device for this Promotion.

3. HOW TO PARTICIPATE. To participate in the Promotion, you must be a registered member of www.foursquare.com. If you are not a registered member of www.foursquare.com, visit www.foursquare.com to register for free and download the free smart phone application. Registration for and use of the foursquare.com system and other Foursquare applications are subject to Foursquare’s terms and conditions, and Six Flags has no responsibility with respect to such registration or use. Once a member, you can begin “checking in” (as described below) to the following Six Flags theme parks (each, a “Participating Park”):

In order to “check into” a Participating Park, a participant must be in or immediately adjacent to the Participating Park’s perimeter and use his or her wireless mobile device to access the foursquare.com system and follow the system’s instructions to “check in” his or her location that corresponds to the Participating Park. **PAYMENT OF PARK ADMISSION OR PARKING IS NOT REQUIRED TO PARTICIPATE IN THE PROMOTION.** During the Participation Period, each Participating Park will

have a “Foursquare Mayor”, who is the participant at any given time during the Participation Period that has the highest number of “check ins” on foursquare.com at the Participating Park. In the event of a dispute as to the identity of a participant, the authorized account holder of the foursquare.com account will be deemed to be the participant. Potential award recipients may be required to show proof of being the authorized account holder. The “authorized account holder” is the natural person assigned to the foursquare.com account by Foursquare. Proof of Foursquare check ins will not be deemed to be proof of receipt of participation information by Sponsors. All participants subject to verification prior to receiving a Promotion award, as are the eligibility, age and other claims of/information provided by a potential award recipient.

NOTE ABOUT MOBILE: Foursquare may only be available via participating wireless carriers. By using Foursquare and/or downloading or transmitting data via your wireless mobile device, standard rates will apply according to the terms and conditions of your service agreement with your wireless carrier. Other charges may apply (such as normal airtime and carrier charges) and may appear on your mobile phone bill or be deducted from your prepaid account balance. Wireless carriers' rate plans may vary, and you should contact your wireless carrier for more information on rate plans and charges relating to your participation in this Promotion. Participation in this Promotion by wireless mobile device means that you understand that you may receive additional messages by mobile device relating to this Promotion, including to notify you if you are a Promotion award recipient, which may be subject to charges pursuant to your carrier's rate plan. Wireless service may not be available in all areas. Check your mobile device's capabilities for specific instructions.

4. PROMOTION AWARD RECIPIENTS AND NOTIFICATION. Subject to the terms and conditions of these Official Terms and Conditions, for each Participating Park, the individual who, at the end of the Promotion Period, is the then current Foursquare Mayor for the Participating Park, will be the potential Promotion award recipient for such Participating Park. There will be a total of up to eleven (11) potential Promotion award recipients (one (1) potential Promotion award recipient per Participating Park). Check ins and the determination of the individual who is the Four Square Mayor for a Participating Park is determined by Foursquare using the foursquare.com system, the determination of which shall be final and binding. The potential Promotion award recipient will be notified using the foursquare.com system. If the potential award recipient cannot be contacted within seven (7) days of the first attempt to contact him/her, or if the potential award recipient is found to be ineligible, or if the potential award recipient does not comply with the Official Terms and Conditions, then the potential award recipient may be disqualified and the alternate award recipient for a Participating Park will be the individual who would have been the Foursquare Mayor for the Participating Park at the end of the Promotion Period if the disqualified individual had not been included. An alternate potential award recipient will be notified as described above. Sponsors are not responsible for the failure of a potential award recipient to receive Sponsors' notification for any reason. In the event of a award forfeiture, no compensation or other payments will be given

5. AWARDS. Subject to these Official Terms and Conditions, eleven (11) awards will be awarded in this Promotion. Each award consists of and is limited to only the following: One (1) Six Flags Season Pass valid for the Six Flags 2011 operating season of the Participating Park for which the award recipient was the Foursquare Mayor. LIMIT: One (1) Promotion award per person and household. A Season Pass is subject to the terms, conditions, limitations and restrictions thereof. Award recipient is subject to all Participating Park rules and regulations. The approximate retail value (“ARV”) of each award in this Promotion is sixty dollars (\$60), and the ARV of all awards in the Promotion is six hundred sixty dollars (\$660). Each award recipient is solely responsible for any and all costs, fees, taxes and expenses associated with the award receipt and use, including, without limitation, transportation costs, lodging, meals, additional costs and upcharges incurred from a ride or attraction, gratuities, insurance, surcharges and other costs and expenses incurred by the award recipient in accepting and using the award, and all

federal, state and local taxes on the award. Awards are non-transferable and non-assignable, and are not refundable, and must be accepted as awarded. 6. AGREEMENT TO OFFICIAL RULES AND DECISIONS. By participating in this Promotion, each participant irrevocably, fully and unconditionally agrees to be bound by and accepts these Official Terms and Conditions, and any other documents, instruments, releases and agreements required under these Official Terms and Conditions, and the decisions of Sponsors (including, without limitation, decisions regarding eligibility of participants, the selection of Promotion award recipients, and the awarding of Promotion awards), which are final and binding in all respects. By participating, each participant waives any right to claim ambiguity in these Official Terms and Conditions and or any other Promotion-related advertising or materials.

By participating, each participant forever and irrevocably releases and holds harmless Sponsors and their respective parents, subsidiaries, affiliates, agents (including advertising and promotion agencies), Promotion partners and award suppliers, and all of the respective employees, officers, directors, shareholders and agents of the foregoing from and against all claims, damages or liabilities arising in whole or in part, directly or indirectly, from participant's participation in the Promotion and/or the award, receipt or use of any award given in this Promotion.
