

## 2015 JUNIOR HIGH GRAD NIGHT STUDENT RULES

## PLEASE READ TO YOUR STUDENTS BEFORE LEAVING YOUR SCHOOL!

Congratulations to all of you! We have a great night full of fun and excitement planned for you.

When you arrive at Six Flags Magic Mountain, please have your wristband on and ticket ready at the turnstiles. Each person must be wearing their wristband and holding their own ticket. All students and chaperones will also be required to go through a security check before entering the park.

There are a few guidelines that we must ask you to follow while at the Park. These rules are established so all guests will have a great time in a safe manner.

- 1. Please stay within the Park at all times. You will not be permitted to exit and re-enter the Park.
- 2. We must insist that you wait your turn in each line. Cutting in lines will not be permitted. Please adhere to this rule so that you avoid being removed from the line and the Park by Security Personnel.
- 3. Disorderly conduct will not be permitted. This means fighting, obscene language, shoplifting, rude behavior towards Park staff & other guests, etc.
- 4. Liquor, illegal drugs or controlled substances are strictly prohibited. You should not attempt to bring any of these items with you on the bus or to the Park. You must dispose of any of the above items immediately. Further, there are a number of restricted items that are listed below and are not allowed into the Park. Any of the following items that are confiscated by Security Personnel during the screening will not be returned:

Alcohol/Illegal Drugs or Controlled Substances

Food

Weapons or any sharp objects

Liquid Paper

Pens, Pencils and Markers of any kind

Skate shoes (a.k.a. Heelys)

- 5. PLEASE LEAVE LARGE BAGS OR BACKPACKS AND ANY OF THE ABOVE LISTED ITEMS AT HOME OR ON THE BUS. THEY WILL NOT BE PERMITTED IN THE PARK.
- 6. If you need to speak to a chaperone, a representative from our staff will be present at chaperone headquarters (*Magic Mountain West Picnic Area*) all evening to help you locate a chaperone.

If you choose to break the rules, you will either spend the evening in the Security Office or your parents will be called to come and pick you up.

## 2015 JUNIOR HIGH GRAD NITE AGREEMENT

This agreement will serve to confirm the arrangements under which students may purchase Grad Night 2015 tickets to Six Flags Magic Mountain. When signed, this letter will constitute the following agreement between us regarding your use of Six Flags Magic Mountain.

- 1. These tickets will be valid for admission on May 15<sup>th</sup> or June 6<sup>th</sup> between the hours of 10:30 AM and 12:00 midnight. The purchasers of such tickets shall have unlimited use of all Six Flags Magic Mountain rides, attractions and amusements ordinarily open to the purchasers of general admission tickets with the exception of selected food and merchandise locations and Bugs Bunny World Children's area normal park closing.
- 2. It is expressly understood that the price of the ticket does not include any game areas, go-kart track, Dive Devil, Cyclone 500, food, drink, or goods for which an additional fee is normally charged.
- 3. It is understood that the use of the park on the ticket date is exclusive to the various participating schools' graduating Junior High class between the hours of 6:00 PM and 12 midnight on May 15<sup>th</sup> and between the hours of 9:00 PM 12 midnight on June 6<sup>th</sup>. The park will not be open to the general public during the aforementioned hours.
- 4. Please understand that on the evening of Grad Night **NO ONE** but those on our authorized school representative list will be able to pick up or purchase additional tickets at our Group Sales Window. Any unauthorized person will be required to wait until the appropriate representative can be located.
- 5. Persons entering the Park will be governed by rules and regulations instituted for the safe and orderly function of Six Flags Magic Mountain.
- 6. Exit gates will be closed once sweep has finished. No one may leave the Park prior to 12:00 midnight unless accompanied by a chaperone.
- 7. No alcohol, illegal drugs or controlled substances are permitted in the park. All students are subject to a protective search prior to entering the Park. **The following items will be confiscated by Security Personnel:**

Food

Alcohol/Illegal Drugs or Controlled Substances

Weapons or any sharp objects

Liquid Paper

Pens, Pencils and Markers of any kind

Skate shoes (a.k.a. Heelys)

If any of the above items are confiscated they will not be returned to the guests.

Please have the students leave large bags or backpacks plus any of the above listed items at home or on the bus. They will not be permitted in the park.

8. There will be a refreshment and relaxation area for the chaperones. The location will be in our <u>West Picnic Pavilion</u>. Chaperones may stay at the chaperone headquarters and will be required to leave a cell phone number that a chaperone can be reached at all times.

*Note*: Bus drivers are **not permitted** in the chaperone area. The food provided is for the chaperones only. <u>Chaperones may not bring their children.</u>

- 9. It will be the responsibility of the chaperones to make sure students are dressed in a neat and clean fashion. School/club jackets or hats are not recommended. We want graduates to be comfortable, but we also must insist on appropriate clothing for our party atmosphere.
- 10. Six Flags Magic Mountain has a strict Code of Conduct for all Guests. A copy of this Code of Conduct has been provided and should be reviewed with chaperones and students prior to their arrival at the Park.
