Minimum Qualifications:

- Must be able to sit, stand, or walk for long periods of time
- For safety purposes, the individual must be able to communicate effectively in the English language, including the ability to read, speak, and understand the English language
- Ability to actively communicate with large groups of Guests
- Be available to work flexible hours on nights and weekends within the limits of applicable Federal, State and facility labor laws and guidelines
- Must pass a background screening
- Currently pursuing a degree in Criminal Justice, Accounting, or Pre-Law
- Must have strong verbal and written skills
- Solid organizational skills
- Must be able to work indoors with artificial lighting and outdoors in all weather conditions
- Proficient in Microsoft Office (Word, Excel, Access, PowerPoint).
- Requires certification as an investigator (Review of manual, online testing, physical training)

EDUCATION	High School diploma or equivalent preferred
EXPERIENCE	Retired Law Enforcement welcome. Pursuing a degree in Criminal Justice, Accounting, or Pre-Law. Prefer at least two years experience in the Loss Prevention field.
COMPLEXITY OF DUTIES	Must possess above average communication skills. Must react well in stressful and emergency situations. Must be able to work in a fast paced environment. Must possess solid organizational skills.
SUPERVISION RECEIVED	Under supervisor and manager supervision.
ERRORS/SAFETY	Errors in performance, mismanaged paperwork, or failure to adhere to and enforce Operations policies as stated in any Standard Operating Procedures Manual may result in civil liability suits against yourself and the company. And may lead to disciplinary action up to and including termination as stated in the park's progressive discipline policy. Must complete training and certification as a technician, field agent, and undercover shopper. Must pass background screening.
CONTACT WITH OTHERS	Direct and continuous interaction with Guests and Team Members on a daily basis. Must possess solid leadership abilities. No Fraternization with IPS / Security / Cash Control employees.
CONFIDENTIAL DATA	Access to confidential information such as reports, park phone listings, safety checklists for attractions, etc. High exposure to confidential data.
MENTAL OR VISUAL DEMAND	Requires normal visual and mental demand.
PHYSICAL DEMAND	Requires sitting, standing, some lifting, walking, bending, eye/hand coordination, near vision, hearing, and speech. Requires kneeling, manual dexterity, gross motor skills, and color definition. Requires using telephone and computer equipment. Strong physical mobility--the ability to move easily in different work stations, hand and arm movement and utilizes safe lifting and carrying techniques. Requires repetitive motions of the wrists, arms and shoulders Must be able to stand/walk for up to 6 hours at a time and as many as 14 hours a day. Must be able to lift 15 lbs. Consistently Must be able to lift and carry 15 lbs. over 25 feet over various surfaces Must be able to climb a ladder up to 6 ft in height.
WORKING CONDITIONS	Continuously works indoors and outdoors and closely with others. Occasionally works alone. Occasionally is exposed to direct sunlight, dust/dirt, and water.
